

ORDINANCE NO. 1679

AN ORDINANCE AMENDING CHAPTER 113.052 OF TITLE XI OF THE 2015 ORDINANCE CODE OF THE CITY OF OWATONNA, AS AMENDED, ENTITLED "LICENSE REQUIRED" FOR BREW PUBS AND BREWER TAPROOMS

THE CITY COUNCIL OF THE CITY OF OWATONNA, MINNESOTA, DO ORDAIN:

Section 1. Chapter 113.063 of Title XI of the 2015 Ordinance Code of the City of Owatonna entitled "License Authorized" is hereby amended with update to Section D - Brewer Off-Sale Malt Liquor License.

BREW PUBS; BREWER TAPROOM

§113.063 LICENSES AUTHORIZED.

(D) Brewer Off-Sale License. A Brewer Off-Sale Malt Liquor License may be issued with approval of the Commissioner of Public Safety, to a holder of a Brewer's License under Minn. Stat. § 340A.301, subd. 6(c) (i) or (j) that meets the criteria established in Minn. Stat. § 340A.28 as may be amended from time to time.

- (1) A brewer may only have one license under this subdivision.
- (2) Hours of Sale. Off-sale of malt liquor shall be limited to the legal hours for off-sale at exclusive liquor stores in the City, as set forth in this Ordinance Code §113.079(B).
- (3) Malt liquor authorized for off-sale must be packaged in a container or combination of containers that is in compliance with the provisions of Minnesota Rules, Parts 7515.1080 to 7515.1120.
- (4) Malt liquor sold off-sale must be removed from the premises before the applicable off-sale closing time at exclusive liquor stores.

(E) Small Brewer Off-Sale License. A Small Brewer Off-Sale Malt Liquor License may be issued, with approval of the Commissioner of Public Safety, to a holder of a Brewer's License under Minn. Stat. §340A.301, subd. 6(c) (i) or (j) that meets the criteria established in Minn. Stat. §340A.28 ("Small brewer

off-sale") as may be amended from time to time.

§ 113.065 LICENSE FEES.

The annual license fees for a Brew Pub On-Sale and Off-Sale License under §113.063. Brewer Taproom On-Sale License, Brewer Off-Sale Malt Liquor License and Small Brewer Off-Sale License and Brewer Temporary On-Sale License and Sunday Sale License shall be in the amounts duly established from time to time by City Council and set forth in the city's Fee Manual.

Section 2. Effective date. This ordinance shall be in full force and effect from and after its passage and publication.


