

City of Owatonna – October 23 – December 18, 2022 Deer Management Rules & Application (MNDNR Special Hunt #990)

Purpose: To cull the herd of deer within the city limits of Owatonna.

Take: Five bag limit per hunter. Antlerless only. Earn-a-Buck after taking one antlerless.

Requirements:

- » 18 years or older, hold Minnesota hunting license, pass review of eligibility by DNR CO.
- » \$20 non-refundable application fee
- » Pass a proficiency test
 - City Archery Range – 711 North Elm Avenue, Owatonna
 - in case of rain – 20 Rifle & Pistol Club – 1675 50th St NW, Medford
- » All Minnesota DNR rules and regulations apply
- » Communicate with park staff weekly
- » Report deer taken to Parks & Recreation within 24 hours in addition to required DNR reporting
- » Use proper hunting etiquette and good judgment

Important Dates:

- » Registration Deadline – September 16th
- » Proficiency Test – September 24th or October 1st from 11 a.m. – 2 p.m.
- » Permits assigned – week of October 10th
- » First Season – October 23rd – November 20th
- » Second Season – November 21st – December 18th

Key Points during Season:

- » Stands may go up after meeting with park staff
- » Stands must be at least 5 feet above ground
- » Hunt within zone boundaries and at designated stand locations
- » No discharge of bow within 150' of any inhabited structure or 100' of main trail
- » No use of crossbows
- » No permanent tree stands or steps
- » No personal trail cameras
- » No cutting or removal of vegetation
- » Bow must be in legal case if not in stand
- » All entails removed intact or containers and disposed of properly
- » No motorized vehicles allowed on trails, remain on roadways or in parking lots
- » Carry city-issued permit into parks (paper or virtual)
- » Stands removed no later than December 30th or subject to seizure & disposal
- » Register deer taken with Special Hunt 990

Location assignments are based on: Proficiency Test points, past program points (hunting & success), hunter preference.
